AMENDMENT NO. 1/2018 (2)

REASON FOR THIS AMENDMENT:

(1) This amendment was made to fulfil the requirements of the Forest Stewardship Council (FSC) certification scheme for forest certification in Malaysia to express policy in the 2nd Forest Management Plan (FMP) stating that the Sabah Forestry Department is committed to manage the project area in accordance with the principles of sustainable forest management as prescribed by the Forest Stewardship Council (FSC).

(2) To replace Amendment No. 1/2017 which was approved on 3rd May 2017.

AMENDMENT NUMBER 1:

 New paragraphs are added under Chapter I: INTRODUCTION (Item 1.4, Page 3) to the Policy Statement. The new statements are as follows:

"The SFD will strive to protect the project area from illegal activities, such as encroachment, hunting, felling and fires, and to enhance the safe, sound and responsible management of the forest for future generations"; and

"The SFD will incorporate procedures for identification and protection of sites with special cultural, ecological, and economic or religious significance to local communities".

This amendment is considered as minor and does not require additional documentation. This amendment has to be read together with the 2nd FMP.
